

ORDINANCE No. 13-99

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA, AMENDING THE TOWN OF DEWEY-HUMBOLDT, ARIZONA CODE OF ORDINANCES, TITLE 111 ADMINISTRATION, CHAPTER 30 TOWN COUNCIL AND OFFICIALS, § 30.018 COUNCIL ACTIONS AND § 30.105 COUNCIL AGENDA RELATED TO REVISING COUNCIL PROCEDURES FOR ITEMS PLACED ON THE AGENDA AT THE REQUEST OF COUNCILMEMBERS; PROVIDING FOR A SAVINGS CLAUSE; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING PENALTIES

Now, Therefore, Be it ordained by the Mayor and Common Council of the Town of Dewey-Humboldt, Arizona, as follows:

Section I. In General

The Town of Dewey-Humboldt, Arizona Code of Ordinances, Title III Administration, Chapter 30 Town Council and Official, Section 30.018 Council Actions is hereby amended to read as follows (additions in ALL CAPS; deletions in ~~strikeout~~):

30.018 Council Actions

* * *

(D) ~~Any Councilmember may suggest an agenda item for the next regular council meeting and the item shall be placed on the agenda.~~ AGENDA ITEMS SUBMITTED BY A COUNCILMEMBER SHALL BE INTRODUCED BY THE SUBMITTING COUNCILMEMBER WITHOUT RESTRICTIONS, INTERFERENCE OR COMMENT FROM OTHER COUNCILMEMBERS, THE MAYOR OR THE PUBLIC. DISCUSSION ON THE ITEM SHALL NOT BE COMMENCED UNTIL THE SUBMITTING COUNCIL MEMBER YIELDS THE FLOOR.

The Town of Dewey-Humboldt, Arizona Code of Ordinances, Title III Administration, Chapter 30 Town Council and Official, 30.105 Council Agenda is hereby amended to read as follows (additions in ALL CAPS; deletions in ~~strikeout~~):

30.105 COUNCIL AGENDA.

* * *

(C) Any member of the Town Council may ~~suggest~~ REQUEST an ITEM BE ADDED TO THE agenda ~~item~~ for the next regular Council meeting and the item

shall be placed on the agenda. A REQUEST TO MODIFY OR REMOVE AN AGENDA ITEM MAY BE MADE BY THE REQUESTING COUNCILMEMBER, IN WHICH CASE IT SHALL BE MODIFIED OR REMOVED WITHOUT FURTHER ACTION. THE MAYOR OR ANY OTHER COUNCILMEMBER MAY REQUEST AN ITEM THAT WAS SUBMITTED BY ANOTHER COUNCILMEMBER BE MODIFIED OR REMOVED, IN WHICH CASE IT MAY ONLY BE MODIFIED OR REMOVED WITH THE CONCURRENCE OF THE COUNCILMEMBER WHO REQUESTED IT BE PUT ON THE AGENDA.

Section II. Savings Clause

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance as amended is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remainder of this Ordinance.

Section III. Repeal of Conflicting Ordinance

All other code provisions, ordinances, or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed as of the effective date hereof.
