

**RESOLUTION N<sup>o</sup> 10-82**

**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA, PROVIDING FOR AGREEMENT TO MAKE APPLICATION AND MEET THE TERMS OF THE ARIZONA DEPARTMENT OF TRANSPORTATION AND UNITED STATES DEPARTMENT OF TRANSPORTATION FEDERAL HIGHWAY ADMINISTRATION TRANSPORTATION ENHANCEMENT GRANT, ROUND 18; PROVIDING THAT THIS RESOLUTION SHALL BE EFFECTIVE AFTER ITS PASSAGE AND APPROVAL ACCORDING TO LAW; AND PROVIDING FOR REPEAL OF ANY RESOLUTION OR PART OF RESOLUTIONS OR CODE PROVISIONS IN CONFLICT THEREWITH.**

**WHEREAS**, the Arizona Transportation Enhancement Program, sponsored by the Arizona Department of Transportation (ADOT) under the direction of the United States Department of Transportation Federal Highway Administration (FHWA), provides grant funding for projects that enhance surface transportation sites; and

**WHEREAS**, the Town of Dewey-Humboldt has developed a Open Space and Trails Master Plan and has included a Trails Element in its General Plan, recognizing its importance to Dewey-Humboldt citizens; and

**WHEREAS**, the Town desires to continue to establish a transportation system to connect neighborhoods, provide links to recreational opportunities and community facilities and activities, and offer an alternate mode of transportation for residents and visitors; and

**WHEREAS**, the Town has determined that a need exists to extend a new, sidewalk from the Huron Street to Hecla Street along Main Street and Prescott Street; and

**WHEREAS**, the Town of Dewey-Humboldt intends to apply for a grant from the Transportation Enhancement Program Round 18 to help fund this sidewalk; and

**WHEREAS**, the grant requires a local government resolution authorizing the application and making commitments to pay the 5.7% match and any overmatch; fund the project scoping document, environmental, right-of-way, utility clearances, and design, if applicable; ready the project for advertisement within three years; pay all cost overruns; reimburse ADOT and FHWA for all federal funds used if the project is canceled by the Town; pay the ADOT review fee of \$3,000 or \$5,000; and commitment to a joint project maintenance agreement.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Town of Dewey-Humboldt, Arizona, hereby approve the submission of an application for an Arizona Transportation Enhancement Program Round 18 grant to help fund the Huron Street to Hecla Street along Main Street and Prescott Street sidewalk.

**BE IT FURTHER RESOLVED** that the Town commits to contribute a minimum cash match of 5.7% and any overmatch; fund the project scoping document, environmental, right-of-way, utility clearances, and design, if applicable; ready the project for advertisement within three years; pay all cost overruns; reimburse ADOT and FHWA for all federal funds used if the project is canceled by the Town; and pay the ADOT review fee of \$3,000 or \$5,000; and commitment to a joint project maintenance agreement.
