



AMENDED SUPPLEMENTAL PROCLAMATION NO. 15 TO THE PROCLAMATION AND DECLARATION OF EMERGENCY DATED APRIL 7, 2020


WHEREAS, pursuant to Arizona Revised Statute (A.R.S.) § 26-311 and Dewey-Humboldt Code of Ordinances § 30.031, and due to the COVID-19 pandemic, on April 7, 2020, Terry Nolan, Mayor of the Town of Dewey-Humboldt, Yavapai County, Arizona, declared a local emergency within the corporate limits of the Town of Dewey-Humboldt, and set forth regulations to preserve the peace and order of the Town, said declaration of emergency initially expiring on April 30, 2020, subsequently extended to expire on April 30, 2021; and is hereby reinstated on December 13, 2021 and extended until further notice because of the resurgence of COVID 19 infections in the tri-city area making it necessary as a matter of public welfare, health and safety as well as for Town staff health protection”.

WHEREAS, the COVID-19 pandemic remains a threat to the health and safety of the citizens of the Town of Dewey-Humboldt as set forth in the Proclamation and Declaration of Emergency of April 7, 2020 and Supplemental Proclamations Nos. 1 through 15;

NOW, THEREFORE, for the reasons specified above I, John Hughes, Mayor of the Town of Dewey-Humboldt, Yavapai County, State of Arizona, pursuant to A.R.S. § 26-301, *et. seq.*, and Dewey-Humboldt Code of Ordinances § 30.031, do hereby proclaim and order that:

1. The Proclamation and Declaration of Emergency dated April 7, 2020, is hereby reinstated on December 13, 2021 and extended until further notice, for the specific purposes set forth below.
 - a. The public meetings of the Town of Dewey-Humboldt Town Council scheduled for December 14th and December 16th are hereby cancelled until further notice.
 - b. All other public meetings of the Town of Dewey-Humboldt, including those of the Town Council and all Boards, Commissions and Committees, are cancelled until further notice.
 - c. Town Hall shall be open only for staff during regular business hours but closed to the public. If you have any questions, please call Town Hall at (928) 632-7362.
 - d. Dewey Humboldt Magistrate Courtroom operations shall be limited to where courtroom activities are held with necessary participants entering directly through the outside door for that room.
2. Any provisions of the Proclamation and Declaration of Emergency and Supplemental Proclamations in conflict herewith are hereby repealed.
3. This Amended Supplemental Proclamation No. 15 shall be effective as of 12:01 a.m. December 13, 2021.
