

ORDINANCE NO. 22-181

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA, AMENDING THE TOWN OF DEWEY-HUMBOLDT, ARIZONA CODE OF ORDINANCES, TITLE III ADMINISTRATION, CHAPTER 34 FINANCES AND TAXATION, § 34.01 FEE SCHEDULE FOR TOWN DOCUMENTS.

Be it ordained by the Mayor and Common Council of the Town of Dewey-Humboldt, Arizona, as follows:

SECTION I. In General

The Town of Dewey-Humboldt, Arizona Code of Ordinances, Title III - Administration, Chapter 34 Finances and Taxation, Section 34.01 Fee Schedule for Town Documents is hereby amended to read as follows (strike out text indicates deletions and underlined UPPERCASE text indicates ADDITIONS to text):

§ 34.01 Fee Schedule for Town Documents.

(B) Documents on file at the town offices: \$0.25 per page ~~plus staff time based on an hourly rate of \$25.00 per hour.~~

SECTION II. Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference, are hereby repealed.

SECTION III. Providing Severability.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.


SECTION IV. Penalties.
