

IMPORTANT VOTING INFORMATION TO THE VOTERS OF THE TOWN OF DEWEY-HUMBOLDT

On **November 8, 2022**, the Town of Dewey-Humboldt will conduct a **Special Election** to consider **Proposition 457**, amending Dewey-Humboldt Town Code 30.015, Town Council Generally for the Town of Dewey-Humboldt.

The **November 8, 2022 Special Election** will be held in conjunction with the statewide November 8, 2022 General Election. You may vote prior to the election date using early voting procedures or in-person on the day of the election *at any* Yavapai County Vote Center. Ballots can be mailed through United States Postal Service or can be dropped off by 7:00 pm on November 8, 2022 *at any* of the Official Yavapai County Ballot Boxes across Yavapai County. The Town of Dewey-Humboldt has an Official Yavapai County Ballot Box OUTSIDE of Town Hall, located at 2735 South Highway 69, Humboldt, AZ 86329.

AZVoter Registration: In order to vote in any election, you must live in the Town's limits, you must have registered to vote at least twenty-nine (29) days prior to the election and meet the requirements listed below. If you do not know if you are qualified to vote, contact the Yavapai County Voter Registration's Office at (928) 771-3248.

Requirements for Registering to be Eligible to Vote in this Special Election:

- You must be a citizen of the United States
- 18 years of age or older preceding the next Special Election
- A resident of the State and the Town at least 29 days preceding November 8, 2022
- · Have not been convicted of a felony or treason, or if so, your civil rights have been restored

Location & Hours for Early Voting In-Person:

- Prescott: Yavapai County Administration Building, 1015 Fair Street from 8 am to 5 pm, Monday through Friday
- Prescott Valley: Prescott Valley Town Hall, 7501 East Skoog Boulevard from 9 am to 4 pm, Monday through Friday
- Cottonwood: Yavapai County Administration Building, 10 South 6th Street from 8 am to 5 pm, Monday through Friday

Early Voting In-Person: To vote early in-person, appear at the office designated for Early Voting no later than 5:00 pm on November 4, 2022. Early Voting will be permitted Monday through Friday during regular business hours from October 12, 2022 through November 4, 2022.

Voting Early by Mail: Yavapai County Recorder's Office will send ballots for this Special Election to all voters who are registered as of October 10, 2022 and on the list of mail-in ballot voters. If you believe you have not received a ballot and you think it is a mistake, a written or telephonic request must be received in the office designated for Early Voting before the close of business on October 28, 2022. On any request, please specify name, residence address, birth date, election for which the ballot is being requested, address where ballot is to be mailed if other than residence address and signature of requester.

Preparation of this Publicity Pamphlet is required by State Law and in compliance with the Federal Voting Rights Act. In order to be prepared to fully exercise your right to vote at the election, you are urged to thoroughly read all the material. PROPOSITION 457 PROPOSED BY INITIATIVE PETITION AMENDING TOWN CODE 30.015 TOWN COUNCIL GENERALLY

OFFICIAL TITLE: § 30.015 TOWN COUNCIL GENERALLY (AMENDED)

<u>DESCRIPTIVE TITLE</u> : A CITIZEN INITIATIVE TO AMEND TOWN CODE 30.015, "TOWN COUNCIL GENERALLY" TO REQUIRE A SUPERMAJORITY VOTE (THREE QUARTERS) OF THE COUNCIL MEMBERS INSTEAD OF A SIMPLE MAJORITY VOTE ON A LOAN FOR NON-POINT SOURCE PROJECT, AND OTHER WATER OR SEWER LOANS FOR TOWN OWNED UTILITIES FROM WATER INFRASTRUCTURE FINANCE AUTHORITY
A "YES" vote shall have the effect of amending Dewey-Humboldt Town Code 30.015, "Town Council Generally" to require a supermajority vote (three quarters) of the council members instead of a simple majority vote on a loan for non-point source project, and other water or sewer loans for town owned utilities from WIFA (Water Infrastructure Finance Authority) or any other source. This is necessary because current state law (ARS 9-571, C., 2) doesn't require the citizens vote to approve such council actions on a WIFA loan of towns our size.
☐ A "NO" vote shall have the effect of retaining existing law regarding majority vote needed for approval of Council actions.

§ 30.015 TOWN COUNCIL GENERALLY. (amended)

- (A) Number and term. The elected officials of the town shall be seven Councilmembers (including the Mayor) who shall constitute the Town Council. Councilmembers shall serve four-year, staggered terms as provided by state law. Each Councilmember shall continue in office until the assumption of duties of office by his or her duly elected and sworn successor. Councilmembers elected in 2011 or appointed to fill the term of a Councilmember elected in 2011 shall serve until the assumption of duties by Councilmembers elected in the Fall 2014 election. Councilmembers elected in the Spring 2013 election shall serve until the assumption of duties by Councilmembers elected in the Fall 2016 election.
- (B) Any form of action permissible. The corporate powers of the town shall be vested in the Council and shall be exercised only as directed or authorized by law. All powers of the Council shall be exercised by ordinance, resolution, order, or motion.
- (C) No artificial limit. The Town Council has the power, in the name of the town, to do and perform all acts and things appropriate to a municipal corporation and the general welfare of its inhabitants, which are not specifically prohibited by the constitution, the town ordinance or state or federal laws.
- (D) Majority rule. The Council acts as a body. Policy is established by majority vote. EXCEPT THAT A SUPER-MAJORITY (THREE QUARTERS) VOTE IS REQUIRED FOR APPROVAL BEFORE THE TOWN IS ALLOWED TO ENTER INTO A FINANCIAL LOAN REPAYMENT AGREEMENT WITH THE WATER INFRASTRUCTURE FINANCE AUTHORITY (WIFA), OR ANY OTHER SOURCE; TO CONSTRUCT, ACQUIRE, OR IMPROVE A WASTEWATER TREATMENT FACILITY, A DRINKING WATER FACILITY, OR A NONPOINT SOURCE PROJECT. IN ALL OTHER MATTERS, a decision of the majority binds the Council to a course of action. The Council majority may be a majority of the quorum of the Council.
- (E) No special powers. No Councilmember has extraordinary powers beyond those of other members (except as may otherwise be provided in state law). All members, including the Mayor, have equal powers.
- (F) One office. No member of the Council is permitted to hold any other town office or town employment (except as may otherwise be provided in the town ordinance).
- (G) Assumption of office. Immediately prior to assumption of the duties of office, each Councilmember shall sign the Council Code of Ethics and take and subscribe to the oath of office. The oath shall be given by the Town Magistrate or by the Town Clerk. Councilmembers of the town shall assume the duties of office at the first regular meeting of the Council in December next following the date of the primary or general election at which the Councilmembers were elected. Assumption of an elected office will result in the automatic resignation of all other town offices, elected or appointed.

ARGUMENTS 'FOR' PROPOSITION 457

Please vote yes on Prop 457. If passed it will make it harder for the town council to accept funding to start a town sewer/water company and fund the engineering plan for it (called a non point source project). Prop 457 will change town codes to require a super majority vote by council members for approval instead of a simple majority vote by members. WHY do this now? At the May 17 2022 council meeting the Mayor stated U.S. Senator Sinema told him funds may be available for a sewer treatment plant in Humboldt. If that happens property owners can be required to pay to hook up and will lose their septic tanks when the town condemns septics. The town sewer can become a monopoly sewer company for the whole town, growing in stages. The June 8 2021 council meeting minutes quote the owner of Humboldt Water saying he is willing to team up with the town for a municipal water company. If that happens the State can refuse new well permits when our wells run dry. Arizona Statute 9-571 doesn't allow a town our size to have an election on this funding issue. The U.S. Bureau of Reclamation estimated the cost of a sewer plant here at over twenty million. And we will pay for water, sewer, sewer hookups and assessments will be added to our taxes for the added value of these improvements. Yes on 457 to STOP big government, big bills, and big big growth.

This is an out right lie and all about control.


