

**ORDINANCE NO. 22-187**

**AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA, AMENDING THE TOWN OF DEWEY-HUMBOLDT, ARIZONA CODE OF ORDINANCES, TITLE XV LAND USAGE, CHAPTER 153 ZONING REGULATIONS, SECTION 153.005 DEFINITIONS TO ADD A DEFINITION FOR AGRITOURISM.**

Be it ordained by the Mayor and Common Council of the Town of Dewey-Humboldt, Arizona, as follows:

**SECTION 153.005 DEFINITIONS.**

The Town of Dewey-Humboldt, Arizona Code of Ordinances, Title XV Land Usage, Chapter 153 Zoning Regulations, Section 153.005 Definitions is hereby amended to add a definition for Agritourism (between the existing definitions for "Adjustment Board" and "Alley") which reads as follows (strike out text indicates deletions and underlined UPPERCASE text indicates ADDITIONS to text):

**§153.005 DEFINITIONS.**


**AGRITOURISM. MEANS ANY ACTIVITY THAT ALLOWS MEMBERS OF THE GENERAL PUBLIC, FOR RECREATIONAL OR EDUCATIONAL PURPOSES, TO VIEW, ENJOY OR PARTICIPATE IN RURAL ACTIVITIES, INCLUDING FARMING, RANCHING, HISTORICAL, CULTURAL, U-PICK, HARVEST-YOUR-OWN PRODUCE OR NATURAL ACTIVITIES AND ATTRACTIONS OCCURRING ON PROPERTY DEFINED AS AGRICULTURAL REAL PROPERTY PURSUANT TO ARIZONA REVISED STATUTES (A.R.S.) SECTION 42-12151 IF THE ACTIVITY IS CONDUCTED IN CONNECTION WITH AND DIRECTLY RELATED TO BUSINESS WHOSE PRIMARY INCOME IS DERIVED FROM PRODUCING LIVESTOCK OR AGRICULTURAL COMMODITIES FOR COMMERCIAL PURPOSES.**




